In the event new executive orders are issued affecting classes you will be notified of any necessary adjustments to class dates and/or locations. Confirmations go out about a week before class if not sooner.

NCSTA MEMBERS may scan and email registrations to ncseptictank@gmail.com scan must be in pdf format. NCSTA membership is an annual membership and must be current to register as a member. NCSTA members do not pay for NCSTA-Sponsored classes. This is included with the membership.
